Information and Instructions to Candidates

1. Application Number generated during the submission of the application online is the Registration Number. This number should be written in all the enclosures.
2. **Allocation of Seats**

3. **Eligibility**

Applicant should be a citizen of India and should have studied class VIII onwards in the state other than Tamilnadu. A certificate of Permanent residence in the format given in **Annexure-I** should be furnished (English version only will be accepted).

The minimum academic requirement is that the candidate must have passed in final examination of 10+2 (Class XII) or its equivalent recognized by any State Board / Central Board or any other Board (other than Tamilnadu) accepted by Anna University, Chennai. The candidates must have studied Mathematics, Physics and Chemistry as compulsory subjects.

- 3.1. **Minimum Eligibility Marks**

4. **Mode of Selection:**

The selection of candidates will be on the basis of **JEE(Main) 2017 All India Rank**.

5. **Counselling**

Candidates will be called for counselling in the order of their merit. Mere attending the counselling will not confer any right/claim implicit or explicit for any candidate for claiming admission. Based on the merit and communal reservation, allotment will be made. **The candidates shortlisted for counselling will be notified in our website on 27.07.2017. The first round of counselling will be held on 02.08.2017 at CSIR-CECRI, Karaikudi, Tamilnadu.**

Candidates have to produce all their original certificates during counselling. If a candidate has deposited all the certificates in an Institution where he/she has already admitted, a letter from the Head of the Institution should be produced to that effect. In such cases only, photocopies of certificates attested by the head of the institution will be accepted for verification. The provisional allotment order will be withheld and it will be released only on production of all the original certificates.

Candidates selected for the programme will be required to join the course immediately after finishing all necessary formalities and payment of fees.

6. Registration number for admission

6.1 Application Number generated during online submission of application is the Registration Number for Admission 2017.

6.2 All the enclosures in the application should bear the Registration Number at the top right corner.

6.3 The Registration Number should be quoted in all future correspondence.

7. Procedure for submission of Application Form

The candidates shall apply only through online by logging on to www.cecri.res.in. The candidates should fill-up online application form and ensure that the application is complete and correct in all aspects before submitting the form. Once the application is submitted, it cannot be modified. The candidate should also send the hard copy (printout) of the filled-in application form duly signed. If the candidates has not uploaded his/her photograph when submitting the online application form, then the candidate should affix his/her recent passport size photograph in the hard copy of the application in the space provided. The permanent residence certificate should bear the signature of the competent authority. Application fee in the form of D.D and all supporting documents should be sent along with the application.

The Demand Draft should be drawn in favour of “**Director, CSIR-CECRI**” payable at Karaikudi.

8. General

8.1. The candidates are required to enclose only the self attested copies of the following certificates along with the application.

- (i) Mark sheet of HSC or Equivalent Examination
- (ii) Mark Sheet of X Standard
- (iii) Transfer Certificate
- (iv) Migration Certificate
- (v) Community Certificate (if applicable)
- (vi) Permanent Residence Certificate
- (vii) Rank card of JEE (Main) 2017 issued by CBSE (downloaded rank card is acceptable)
- (viii) Aadhaar card
- (ix) A Demand draft for Rs.500/- or Rs.250/- towards application fee

Note:

- If the original certificates are not in Hindi/English, duly certified Hindi/English version translation of such certificates will be required at the time of reporting for counselling.
- Certificate of category of OBC (central list), if applicable, is to be issued by the competent authority in the prescribed format and should clearly mention that the candidate belongs to Non Creamy Layer. The certificate should have been issued on or after 1st April 2017.

Non-Creamy Layer OBC Certificate issued prior to 1st April 2017 shall not be accepted in any case.

8.2. Applications received after the due date, not in the prescribed form, not correctly filled up or the prescribed certificates and documents not enclosed or do not otherwise fulfil the terms of the instructions, will be considered defective and are liable for rejection without notice. CSIR-CECRI will not be responsible for postal delay or otherwise in respect of receipt of application after the due date. No correspondence will be entertained in this respect.

8.3 The candidates are informed that admission given at the time of counselling is only provisional. In accordance with rules prescribed for admission, if they are found ineligible on actual verification of original certificates / particulars by the CSIR-CECRI / DOTE / Anna University, they cannot claim any right for admission or continuation of study at any stage.

Further, the confirmation of admission is subject to verification of marks / certificates by the authorities. If the mark sheet is found to be not a genuine one,

- (i) Admission is liable for cancellation at any stage of study.
- (ii) The candidate will be debarred from pursuing any course of study for a period of 3 years.
- (iii) Legal action will be taken against the candidate for furnishing forged documents.

1. The Original Certificate should be signed by the Officer of the Revenue Department not below the rank of a Tahsildar in the District concerned or by the Block Development Officer–Cum–Panchayat Union Commissioner in the Block concerned.
2. The certificates should bear the stamp of the office of the Officer signing the certificate. The certifying officer should insist upon clear proof of the permanent residence of the parent or guardian of the candidate and satisfy himself of the genuineness of the residential qualification.
3. The State of Permanent Residence of a candidate's guardian will be taken into account only if both the parents of the candidate are not alive. The relationship of the guardian to the candidate should also be mentioned. If both the parents are alive, only the State of Permanent Residence of father should be taken into account.
